ADOPTION OF AGENDA

Commissioner Kelly moved, and Commissioner Dunning seconded, to adopt the agenda as presented. Motion unanimously carried.

APPROVAL OF MINUTES

Commissioner Fredrickson requested the minutes of the January 26, 2023, Port Commissioner meeting be amended on page 3, Purchase and Sale Agreement-Avery Business Park-Crosland Barnes Group, LLC, to reflect a change from "Attachment A-1" to "Attachment A-1 of the staff report" and Walla Walla Regional Airport, Runway Safety Area Authorization to Bid & Grant Application to change the word "aafety" to "safety." Commissioner Kelly moved, and Commissioner Dunning seconded, to approve the

minutes of the Port Commission meeting held on Thursday, January 26, 2023, as amended. Motion passed unanimously.

FINANCIAL REPORTING

Port Auditor/Treasurer Pritcher reviewed with Commissioners the Cash Balance Report and provided Aged Reports for both the Port and the Airport.

PAYMENT OF BILLS

The Port Commission reviewed Port and Airport Check History Report lists as provided by Port Auditor/Treasurer Pritcher. Said lists were audited, authenticated, and certified as required per RCW 42.24.080 and reimbursement claims were certified as required by RCW 42.24.090. Commissioner Dunning moved, and Commissioner Kelly seconded, to approve for payment, those Check History Report lists summarized in the February 09, 2023, Warrant Approval Document, which is incorporated and attached to these minutes. Motion unanimously carried.

OLD BUSINESS

A. Walla Walla Regional Airport

1. Civil Air Patrol Lease Agreement

Airport Manager Skoglund reviewed the proposed lease terms for space in barrel hangar 101 for the Civil Air Patrol. Commissioners asked several questions. Commissioner Dunning moved, and Commissioner Kelly seconded, to authorize the Executive Director to enter into a lease agreement with Twin W Composite Squadron (CAP) for barrel hangar 101 offices, contingent upon CAP providing the insurance requirements as designated in Exhibit 1 of the staff report, in the amount of \$150.00 per month which includes base rent, base sewer, base water, and base electrical. In addition, CAP is to pay for actual water and sewer consumption fees and natural gas service. Motion passed unanimously.

NEW BUSINESS

A. Port of Walla Walla

1. RFP – Bid Project PWW 2023-100M – Port Property Weed Spraying
Economic Development Director Gerola reviewed with Commissioners the
two bid packages that were received for the weed spraying services for
various Port-owned properties located in Walla Walla County.
Commissioners asked several questions. Commissioner Kelly moved, and
Commissioner Dunning seconded, to authorize the Executive Director to
prepare and enter into a Service Contract with L-C Applicators, Inc. of
Waitsburg, WA for Port property weed spraying and to execute the
necessary documents to complete the service contract upon legal counsel
review and approval. Motion passed unanimously.

B. Walla Walla Regional Airport

1. Bid Project WWRA 2023-Spray Contract

Airport Manager Skoglund reviewed with Commissioners the two bid packages that were received for the weed spraying services for various Airport-owned properties. Commissioners asked several questions. Commissioner Dunning moved, and Commissioner Kelly seconded, to authorize the Executive Director to prepare and enter into a service contract with Smith Brothers Landscaping for Airport property weed spraying and to execute the necessary documents to complete the service contract upon legal counsel review and approval. Motion passed unanimously.

2. AIP Taxiway Seal Coating & Grading Engineering Agreement
Airport Manager Skoglund presented the proposed taxiway maintenance
project and reviewed with Commissioners the taxiway reconstruction
project that took place in 2018. Commissioners asked several questions.
Commissioner Dunning moved, and Commissioner Kelly seconded, to
authorize the Executive Director to enter into a task order with Mead &
Hunt Engineering for design through construction assistance engineering
scope of work for the taxiway pavement maintenance project in the
amount of \$99,660 contingent upon FAA approval. Motion passed
unanimously.
