The Monthly Employment Report

February 2024

On a seasonally adjusted basis, preliminary estimates from the federal Bureau of Labor Statistics (BLS) indicate nonfarm employment in Washington increased by 2,600 in February 2024. BLS estimates that employment in the private sector expanded by 1,300 jobs over the month and employers in the public sector also added 1,300 jobs.

On a not seasonally adjusted basis, estimates for February 2023 through February 2024 indicate an increase in employment of 52,000 for the state. The private sector added 31,300 jobs while the public sector gained an estimated 20,700 jobs over the year.

Washington's preliminary seasonally adjusted unemployment rate for February 2024 was 4.7%. The revised estimated unemployment rate for January 2024 was 4.6%. The unemployment rate in February 2023 was 4.6%.

BLS estimates of monthly job gains and losses are based on a survey of businesses. Preliminary estimates are subject to revision. The January 2024 preliminary estimated loss of 3,600 jobs was revised to a smaller loss of 00 jobs.

^a Most of the employment numbers discussed in this report refer to jobs, not people. For example, if a person holds two positions, these positions are counted as two jobs in the employment series. In the section titled "Unemployment," these positions refer to individuals, not jobs. In this case, a person holding two jobs is counted only once.

Resident civilian labor force and unemployment, seasonally adjusted

The resident civilian labor force is the total number of people in the workforce, employed and unemployed, ages 16 and up.


The number of unemployed is the estimated number of people who currently do not have a job, are available for work and have actively looked for work in the last four weeks.

The unemployment rate is the ratio of the estimated number of unemployed divided by the civilian labor force.






